SUBJECT: Interim Authorization to Operate (IATO) and Authorization to Connect (ATC) for CALLEGRA Version 6.14 (Authorization Termination Date [ATD]: 13 Jan 10)

1. As the system Designated Accrediting Authority (DAA), I hereby grant an IATO for CALLEGRA version 6.14. The Air Force Certifying Authority has provided a preliminary risk assessment based on the information available and find the risk to the Air Force Global Information Grid (AF-GIG) is low.
2. Further, as AFNetOps/CC, I hereby grant CALLEGRA version 6.14 an ATC to connect to the AF-GIG interfacing the NIPRNet.
3. My decision to grant this IATO and ATC is based on the certification determination of the AF Certifying Authority and supported by the analysis of the Information Technology Lean Database, DIACAP artifacts and supporting documentation. I expect the system owner to complete the DIACAP process and obtain the Certifying Authority Recommendation for an ATO before this IATO expires.
4. This accreditation and connection authorization is valid until the ATD specified above. Reaccreditation will be required sooner if there is any change affecting the security posture, architecture or configuration of the system. Operations outside the boundaries of the references specified above will invalidate this approval and are cause to revoke or rescind this authorization.
5. It is the responsibility of the senior official in charge of the system at each implementation location to ensure any change in configuration, mode of operation, or other modification is analyzed to determine system security impact(s); is appropriately addressed through the CALLEGRA version 6.14 configuration management process; and is properly acted upon to maintain a level of security consistent with the requirements established in the Enterprise Information Technology Data Repository (EITDR) and DIACAP Comprehensive Package. Further, the Information Assurance Manager must ensure annual reviews are conducted IAW FISMA/DIACAP and the results are entered in the EITDR. The certifying agency will update the EITDR accordingly, and ensure a copy of this accreditation letter remains on file with any related support documentation.

6. This decision is for this version only as implemented in the aforesaid documentation.
